### **1. General**

1.1 The following License Agreement represents the contractual conditions between you ("Licensee") and Alessandro Baticci, Hohlweggasse 37/32, 1030 Vienna ("Baticci LAB") for the use of software including related media, documentation (for example program descriptions, manuals) and other documents and materials manufactured by Baticci LAB ("Product(s)").

### **2. Scope of Use**

2.1 The intellectual property of the Products remains at Baticci LAB. Licensee acquires only the right to use the Product to the following extent. Any other use or exploitation not explicitly granted to Licensee in this EULA shall not be allowed without written consent from Baticci LAB. Specifically, Licensee is not entitled to copy or have copied, decompile or have decompiled, reverse engineer or have reverse engineered the Product or parts thereof. Licensee must ensure by appropriate and reasonable steps that third parties, including its own employees, cannot make unauthorized use of the Product.

2.2 Baticci LAB grants Licensee the non-exclusive right without restrictions in time or place to use the Products. Baticci LAB is not obliged to cede the software underlying source code, including the associated development documentation.



2.3 Licensee may download and personally use the licensed software and samples on all his devices (e.g. one computer, laptop, workstation), provided that the said software is used only on by him. The Products may not be used on a network by multiple users, unless each user possesses a license. In case Licensee changes the hardware, all software on the hardware used must be deleted.

2.4 Licensee is authorized to modify the software, use it's samples and modify them.

2.5 Licensee shall not, except as otherwise expressly provided herein, decompile, reverse engineer, sell, resell, lease, license, distribute or otherwise transfer the Product or any derivative work thereof. Licensee shall not sell, resell, lease or license any of the samples or any derivative work thereof.

2.6 Licensee is authorized to use the sample library and the samples for commercial purpose, provided that he credits Baticci LAB, by stating his name and adding link to website on T&C or License of Use of any product, video, track or musical sample where the samples are used.
